

# BETHEL PARK SOCCER ASSOCIATION BOARD MEETING – July 08, 2008

**Treasurer's Report:** Bill Wolf gave a balance in the checking and savings accounts of \$26,747.80. Bill Wolf also stated that Jack Kun has agreed to perform an audit on BPSA And file our return.

## **Registration -**

 Don Snyder stated that BPSA had 331 kids registered for flights and still had 2 weeks remaining for registration and 190 kids registered for travel and that registration was now over.

- Tony Bruno also said that he would personally be in contact with Gary Lefevre to Be sure that BPSA is getting their 10% as host to any organization holding a soccer camp or academy in Bethel Park.
- Bill wolf also stated that we had agreed to donate \$125.00 toward a banner at Park Avenue School.
- Tony Bruno and Bill Wolf also wished to thank both Alan Duda and Sherwin Williams for the donation of field paint which represents a savings of over \$1000.00 to BPSA.
- Bill Wolf also stated that the River Hounds had requested to use our nets for Their 3 V 3 tournament being held on 8/9 and 8/30 at the Victory fields in Washington, Pa. In return the River Hounds have agreed to furnish 2 Team jerseys autographed by the entire team.

# Player/Coach Development -

- Larry Shaw also stated the importance of keeping the better players together And that their development would suffer if put together with less developed players. Larry also stated that this was the purpose of holding player tryouts in the first place in order to determine the best way to field an A and a B team. Larry Also stated that BPSA was not a cup organization and that if we failed to Allow for the better players to play on an A team and train with an A team BPSA Risks loosing a lot of kids to cup programs.

Furthurmore, Since BPSA is not a cup program Larry stated that we must develop all of the kids at whatever their skill level.
