

# **BETHEL PARK SOCCER ASSOCIATION BOARD MEETING – February 10, 2009**



**Bill Wolf**, President of the Bethel Park Soccer Association (BPSA) called the meeting to order at 7:07 PM in the Caucus Room of the Bethel Park Municipal Building. Also present were Brian Gorges, Kathleen Tischler, Tony Bruno, Bob Monte, Kelly Mehalko, Jodi Galietta, Ron Kotkiewicz, Dave Conely, JJ Zekany, Michelle Friday, Matt Yee and Gary Lafever.

**Secretary's Report:** Minutes were distributed & reviewed at the meeting. Motion was made by Brian Gorges and seconded by Jodi Galietta to approve the amended minutes & post to the website. The motion passed unanimously.

## Treasurer's Report:

- Balance in the checking and savings accounts of \$42,795.00.
- Coaches' appreciation event invoices are still outstanding.
- Signing authority on bank accounts has been finalized for JJ Zekany, Brian Gorges & Bill Wolf.
- 12 month CD was opened in the amount of \$5000 with 1.21 annual percentage vield.

## **President's Report:** In his state of the Association report, Bill Wolf stated:

- U-10 Issue Extensive discussion took place regarding the team placement of u10 travel players. Circumstances surrounding an incident in which an act of aggression against a fellow team player took place during the fall season, resulting in disciplinary action, & future guidelines for behavior were discussed in preparation for 2/11/09 meeting with parents and select board members. Gary Lafever provided input on behalf of the BP Recreation in regard to meeting attendees, details contained in email from Matt Scott regarding the situation and the process and documentation required to document all player incidents and resulting actions.
- Travel registration has now closed. See committee information.
- On line registration as promoted at USSF event was utilized by several clubs and funds were not received and is not recommended at this time.

 Jodi Galietta is working with Don Snyder during the registration process for the spring season and will meet with JJ Zekany and Michelle Friday with detailed information going forward.

- Brian Gorges attended the field coalition meeting. He reported that the fields will
  not be open until April 1. He reported that BPSA will have the same usage in
  spring as we had in the fall with the exception of Wednesdays at Park Avenue
  which will be coordinated with lacrosse.
- Millenium will be lined accordingly to accommodate 11 v 11.
- Brian presented the field-by-field improvement list to Jim Gastgeb and Gary Lafever. Documentation is now on file.
- Brian discussed usage of Millenium Field by BP Jr. Football with Jim Gastgeb and per email response they will continue to use this field & declining the Village Green option; however, possibility of additional watering is being considered to reduce impact.

**Motion**: Ban all smoking and tobacco usage at BPSA events, games, and practices.

Village, Millennium and Park Ave fields are municipal fields and have no official ban in place. We, as a board, can vote to ban smoking and tobacco usage at any BPSA games and practices. The municipality strongly encourages this action.

Neil, Ben, the High School and all other school fields are covered by:

PA School Code Act 128 of 2000 prohibits the use or possession of tobacco by students or any other persons in school buildings, on buses, or any other property under the control of a school district.
