

# **BETHEL PARK SOCCER ASSOCIATION BOARD MEETING – June 9, 2009**

**Secretary's Report:** Minutes were distributed & reviewed at the meeting. Motion was made by Steve Donovan and seconded by Bob Monte to approve the minutes & post to the website. The motion passed unanimously.

# **Treasurer's Report:**

- Balance in the checking and savings accounts of \$42,188.92.
- A CD will be purchased in the amount of \$5K or \$7K.
- \$23,115 was received from BP Rec Department.
- Invoices to be paid yet include: Justin Fleischmann & ref reimbursement, field lining, sling bags, paint for fields, Larry Shaw coaching fee, and last portion of MLS coaching fee.

# **President's Report:**

- Bill Wolf attended the PA West hearing on behalf of BPSA regarding the Matt Scott suspension and due diligence. Although PA West findings concluded that the association did not follow due; no sanctions were imposed. The board vote last month had already reinstated Matt Scott and the matter was closed.
- Bill Wolf thanked the board for all their efforts and time to make this past season a success.
- He stated the refs were well organized and did a great job as well.

- Ref reimbursement for fall was completed and with only spring reimbursement remaining to be paid.
- Bob stated overall things went very well with refs; however, there is an opportunity for improvement regarding late notice for game cancellations. Discussion took place and decision made that coaches need to cancel directly with refs assigned to game if the game is cancelled after Friday at 9 pm.
- U15 ref incident with issues regarding players' ages resulted in removal of coaches.

- 118 travel registrations. No u14 or u16 boys or girls in the fall due to the school season.
- June 18 will be a travel coaches meeting at the Community Center at which time paperwork deadlines for registration will be discussed.
