- Bill Wolf met with Anthony Wilkerson of MLS and reviewed the contract proposal of which the key points were:
  - No housing request and no additional fee for not housing coaches.
  - No minimum spend.
  - We will pay 50% of first season up front.
  - Same number of coaches as last contract. It was noted that in the past season the organization saw much better utilization of MLS over previous seasons. Further utilization opportunities were discussed such as scheduling like age groups together for practices to further utilize MLS.
